**Sale of Well #3 Water to SLHD-** George Wilson made a motion, seconded by Linda James to approve the sale of water from Well #3 to SLHD. There will be an agreement written with the following:

City of Genesee will not be held responsible for any damages including any site contamination at the water tank location

There will be no outside sales of this water allowed, Use of this water is limited to SLDH SLHD must obtain and install a lock out on the water tank

The agreement will be a 1 year renewable agreement, on the 1<sup>st</sup> of May of each year beginning 2012, with a 60 day cancellation

\$4.00 per 1,000 gallons.

SLHD will report the usage from the meter in a timely manner
