**CALL TO ORDER** - The Genesee City Council met in regular session on May 1, 2012. Mayor Steve Odenborg called the meeting to order at 7:00 p.m.

**ROLL CALL** – Present at the meeting were council members Ron Zenner, Cathleen Blevins, Linda James, Ryan Banks, City Planner and Grant Writer Jim Stravens, Maintenance Supervisor Dustin Brinkly and City Clerk Karyn Wright.

**VISITORS:** Richard “ Ritchie” Skiles~ LC Sheriff Candidate, William Wargo, Thomas O'Brien Ritchie introduced himself to Council as a candidate for LC Sheriff. William Wargo and Thomas O'Brien discussed the sewer issue at 134 N Tamarack. They were told the sewer line would be installed in July and they can do their connections at that time.

**CITY OFFICIAL, COUNCIL AND STAFF REPORTS-**

**Linda James- Fire, Police and Administrative-** Linda reported on the Arbor Day celebration at the school.

**Cathleen Blevins- Parks and Recreation-** Cathleen will be buying the flowers for the planters and suggested the City have a community clean up day on May 19.

**Ryan Banks- Streets-** Ryan reported on the chip seal project. We are getting prices and will be making a decision soon. He suggested the council help prepare for community day by painting the curbs and planters.

**Ron Zenner- Water and Sewer-** Ron had Dustin report on these. Dustin informed council of a purchase for the pump at the lift station by the ball park. Council approved the purchase of a large animal trap for approx \$160.00 and a heavy duty lap top for approx. \$1400.00.

**Jim Stravens-** Jim encouraged council to begin updated the Comprehensive Plan, Transportation Plan, Pavement Management Plan, Capital Improvement Plan and enroll in the T2 program. These need to be completed by Oct. 1.
