**CALL TO ORDER** - The Genesee City Council met in regular session on February 4, 2014. Mayor Steve Odenborg called the meeting to order at 7:00 p.m.

**ROLL CALL** – Present at the meeting were council members Edie McLachlan, Ryan Banks, Cathleen Blevins, Art Lindquist, City Employee Karyn Wright and City Engineer Jack Hammond.

**VISITORS Wendy Moore~ Genesee School District, Roger Falen, Bill Krick~ Genesee Fire Dept, Jay Meyers~ Genesee Rec. Dist, Darrel Stout~ Genesee Rec. Dist.**

Wendy Moore was asked to attend the Council meeting to discuss issues at the school. Ryan Banks addressed Mrs. Moore with a concern of loading and unloading kids on N. Tamarack. Mrs. Moore is unaware of problems in this area. Mrs. Moore expressed her concern of the traffic issues on Ash and N. Elm. After a discussion, Ryan asked Mrs. Moore to look into the concern of safety at the Tamarack and Ash intersection. It was decided this issue would be discussed at a later date. Ryan asked Mrs. Moore if the school would be interested in a joint effort for a new reader board. Mrs. Moore informed Ryan that the school already posts school news on the PNW reader board.

Cathleen asked Mrs. Moore if the younger kids could help clean up the park before the Easter Egg Hunt. Mrs. Moore was in agreement to this request.

Bill Krick is the new Fire Chief. He has 2 applications for firemen that will be reviewed during the New Business of the meeting.

Darrel Stout and Jay Meyer were in attendance to discuss the requested opening of the alley north of their newly purchased property and south of Oak Street.

Roger Falen has an application for an Encroachment Agreement that will be reviewed and voted on during the Unfinished Business.

**Ryan Banks- Streets-** We will have reps from Gritman at the Feb. 18<sup>th</sup> meeting.

**Art Lindquist- Fire and Police-** ICRMP offers online classes on supervisor, leadership, harassment and liability training. They also offer a training coordinator that comes to the area to give these classes. Art would like to see the Council and Mayor take these classes.

Well #3 last nitrate test was 10.2. Council approved Jack to begin work on the water blending station, with an approx. cost of \$25,000.00.

**Mayor Odenborg-** Will speak with Genesee Food Center about the cardboard boxes, Brad Flodin about replacing sidewalks on Walnut Street, Ellen Vieth about personal items on city right of way at her house.
