**CALL TO ORDER** - The Genesee City Council met September 3, 2019. Mayor, Steve Odenborg, called the meeting to order at 7:00pm.

Mayor Odenborg opened the Public Hearing at 7:01pm to run concurrently with the regular Council Meeting. Mayor read each resolution aloud. Discussions regarding rate increases: Visitor comment: it's getting expensive to live in Genesee. It was also mentioned if the City is asking their residents to pass a Bond in November, to replace our waste water facility, they shouldn't ask for any additional increases.

The \$20 sewer increase, has been used for EPA required improvements. After the \$5 increase is implemented in October, the City is hoping it will cover the cost of our new waste water facility. There were also questions about the Circuit Breaker program and who qualifies for lower increases.

The City has received \$243K in grants from DEQ and two \$750K from the Army Corp of Engineers. DEQ will provide, to the City, a low interest loan at 1.75%.

It was also questioned why the waste water situation was never mentioned before the vote on the new Fire Station, which raised property taxes.

No disagreement, the City needs more money to maintain our water system, it was argued that we should take care of one thing at a time instead of raising everything.

Mayor closed the Public Hearing at 8:03pm

Nyla would like to attend and Ryan will check his schedule. Scott is working with Nyla to update our Comprehensive Plan with trails, hoping to get grants for help.

Also mentioned the Veterans Park shouldn't be affected when the football field moves, during the rec district construction. Reported the RV Park made \$2875 for the month of August. **Debi-**No Report
