Linda Chilson- From the Friends of the Library. Read a statement. (Complained about the restroom in the Sr. Center).

Toby Erlenmeyer: Asking for unlimited access to the Sr. Center, requesting back parking lot for Sr. Center use, a full independent audit on grant funds received in 1990-91, full accounting of rental money received for the use of the Senior Center, to rescind or remove Ord 420, both restrooms opened back up, handicap ramp made accessible.

**CITY OFFICIAL, COUNCIL AND STAFF REPORTS**

**John Hermann-** Land purchase for the sewer project has been completed.

**Bill Krick- Water and Sewer Update and Well #8** – Water- We received approval on the Water Rights Permit. Digwell Idaho is still planning on being in Genesee around the end of the month. They received the letter on the liquidated damages and they understand. Bill explained again why we are still working with Digwell. A different driller would be 2 years out on their waiting list. Well #8 will not be online by summer of 2022. Well #3 will be turned on, along with Well #5. The drinking water station will be available for those who want it. We do not expect any kind of water shortage or water restrictions for this summer. This information will be included in the next Newsletter.

**Cody Bailey- Street Update** LHTAC has gone out to bid. Bid opening is March 15. Bids must be within 10% of projected costs ( over ) or 25% ( under) in order to be approved. ( a visitor in the audience complained about the terrible ending results of Jackson St Project. ) Cody asked Chelsey Wallace to resend the email with the broadband information. She mentioned the Conceptual Plan button on the web page is not working.


**Jesse Aherin-Administrative Update**—The Senior Center is open for full use. There will be a lock installed on the unisex bathroom.

**Nyla Roach- Parks Update**—Reviewed the Blue Cross grant opportunity. She is looking for ideas. Grant application is due by the end of February.


