CALL TO ORDER - The Genesee City Council met October 18, 2022; Mayor John Hermann called the meeting to order at 6:00pm.

ROLL CALL: Present at the meeting were Council Members: Bill Krick, Nyla Roach, Jesse Aherin and Cody Bailey; Maintenance Supervisor Dustin Brinkly, City Engineer Scott Becker, City Clerk Karyn Wright and Deputy City Clerk Debi Zenner

VISITORS: Ryan Rehder, Mountain Waterworks and Nancy Feigenbutz

CONSENT AGENDA - Motion made by Bill, seconded by Nyla to accept the consent agenda as presented, along with payment of the bills. We don't have a Financial Statement, so it will be presented at the next meeting.

ROLL CALL VOTE: Krick, Roach, Aherin, Bailey; motion carries.

UNFINISHED BUSINESS:

Well #8 and #9 update - Ryan Rehder gave an overview of Well #8 and discussed casing and completing the Well. Ryan has been assured, by Digwell Idaho, as soon as materials are shipped from Texas, they will mobilize and get back to complete the Well. Ryan discussed the pump tests with so much water; approximately, 400 gallons per minutes, we'll have to have some contingencies in place for the water to flow. The pump house is already designed and both Wells will run through it. All of the steel products are required to be American made, which could cause delivery delays. Hoping to have pump testing done by the end of November.

Sewer Update - Wastewater Update: Ryan said they have put together the funding application utilizing the ARPA funds and should have this ready to go out the end of next week. He also discussed additional applications that will be submitted later for both wastewater and water.

This paragraph does not apply to filling a vacancy in an elective office or deliberations about staffing needs in general; **ROLL CALL: Krick, Roach, Aherin, Bailey; Motion Passes**


